# Dr. Colin D. MacLeod, B.Sc., M.Sc., Ph.D.

#### **PROFILE**

I am an active scientist working in the field of ecology and evolutionary biology. Currently, my main areas of research are: 1. Implications of starvation-predation risk trade-offs for impacts of environmental change on the spatial distribution of animals; 2. Examining the effects of climate change on cetaceans; 3. The use of species distribution modelling (SDM) for environmental impact assessment purposes; 4. Investigating the relationship between body mass and investment in male reproductive tissues in vertebrates. I am an expert in Geographic Information Systems (GIS), spatial modelling and non-linear statistics. In addition, I am recognised as one of the world's foremost experts in studying the effects of climate change on cetaceans, and on beaked whales (Family Ziphiidae).

I have authored 47 peer-reviewed papers, of which I am the first author of 29.
